DECREE

IN THE NAME OF GOD. AMEN.

"Likewise, parishes which are too small should be united insofar as the situation demands it and circumstances permit." St. Paul VI, Apostolic Letter *motu proprio*, *Ecclesiae Sanctae*, n. 21, (1), August 6, 1966

Changing demographics have affected the size and wealth of the Archdiocese of Chicago and the vitality of her parishes. This is particularly true in the City of Chicago itself, where the total population has decreased by nearly 20% since 1970, from 3,366,957 to an estimated 2,705,994 in 2018. The archdiocese has many vacant, old, and underused parochial buildings and fewer priests to pastor our faith communities.

According to the US Census Bureau, the Archdiocese of Chicago had an estimated total population of 5,881,250 in 2018. The 2018 *Annuario Pontifico* indicates our archdiocese had 345 parishes serving a Catholic population of 2,512,000: an average of 7,281 Catholics per parish. According to the same source, the Archdiocese of Los Angeles had a total population of 11,519,517, with 287 parishes for a Catholic population of 4,362,000: an average 15,199 Catholics per parish. For the Archdiocese of New York, the figures are 2,656,987 Catholics in 294 parishes: an average 9,037 Catholics per parish. A good number of our parishes were founded in the first half of the last century or earlier. Many were established for national, linguistic, or ethnic groups that no longer live in the archdiocese or in the neighborhoods where they once flourished.

Too many of our parishes have been unable to support themselves and have been receiving financial subsidies from the archdiocese. Between fiscal year 2012 and fiscal year 2018 these subsidies amounted to \$144,373,461.00, including \$38,171,840.00 to 106 parishes, and \$106,201,621.00 to 83 Catholic schools. In fiscal year 2019 our generous people contributed an additional \$4,448,745.00 to at least 78 of our parishes and \$13,511,371.00 to 76 Catholic schools in the archdiocese. We cannot continue this level of financial support for parishes and Catholic schools. Our hope is that our parishes will become more vital, that is, active centers of Christian discipleship, evangelical mission, scholarship, and charitable outreach. To achieve this hope, the parishes must be able to support themselves when possible.

Almost four years ago, inspired by the experience of St. Francis of Assisi before the cross of the ruined church of San Damiano, and by the Holy Father's dream of "a missionary option ... capable of transforming everything" (Pope Francis, Apostolic Exhortation *Evangelii Gaudium*, n. 27, November 24, 2013), I announced the inauguration of *Renew My Church (RMC)*, a multi-year, intentional process aimed at obtaining and preserving the vitality of our parishes. It is my

intention that every parish of the Archdiocese of Chicago join with some of its neighbors and plan together for the future. Careful planning will create a menu of possible options for future vitality. We are identifying parishes likely to be reconfigured through pastoral coordination with neighboring parishes, divisions, unions, and other significant alterations.

This decree concerns the Lemont Grouping in the far southwest portion of Cook County adjacent to the boundaries of Will and DuPage Counties. Specifically, the grouping encompasses four parishes in the Village of Lemont. These parishes include St. James at Sag Bridge Parish (established 1833), 10600 South Archer Avenue, Lemont, Illinois 60439-9344; St. Patrick Parish (organized 1840), 200 East Illinois Street, Lemont, Illinois 60439-3612; St. Alphonsus Parish (church established 1867, established 1874 as personal parish for Germanspeaking Catholics), 210 East Logan Street, Lemont, Illinois 60439-4207; SS. Cyril and Methodius Parish (established 1882 as personal parish for Polish-speaking Catholics), 608 Sobieski Street, Lemont, Illinois 60439-4050.

In addition to these four parishes there are three additional quasi-parochial communities within the Village of Lemont or the adjacent Village of Willow Springs: Blessed Jurgis Matulaitis Lithuanian Catholic Mission (established 1990), 14911 127th Street, Lemont, Illinois 60439-7417; Blessed Anton Martin Slomsek Slovenian Catholic Mission (established 1994), 14246 Main Street, Lemont, Illinois 60439-0608; and Our Lady Mother of the Church Polish Mission (established 2003), 116 Hilton Street, Willow Springs, Illinois 60480. Here we focus primarily on SS. Cyril and Methodius Parish, but secondarily on St. Patrick Parish.

Throughout 2019, the pastoral leadership and lay representatives from the four Lemont parishes, met in an *RMC* grouping to consider the future vitality of their area of the archdiocese. The Grouping Team presented a Community Engagement and Planning Feedback Summary to the Archdiocesan Standards and Recommendations Commission, a group formed by lay and ordained representatives from across the archdiocese. With respect to the two parishes of our focus, the proposal to be put before the Presbyteral Council is that SS. Cyril and Methodius Parish cease as a personal parish and be reorganized as a territorial parish with territory taken from St. Patrick Parish.

The proposal is supported by the data and arguments mentioned herein or attached to this decree. Significant is the slight decline in Sunday Mass attendance at SS. Cyril and Methodius Parish over the last 20 years. Recent Sunday Mass attendance has been 1,837 at SS. Cyril and Methodius Parish (approx. 34% at Polish Masses). In fiscal year 2018 the operating income of SS. Cyril and Methodius Parish was \$1,215,210.00.

THEREFORE, know that I, Cardinal Blase J. Cupich, Archbishop of Chicago, according to the norms of canon 50, canon 127 §§1 & 3, canon 166, and canon 515 §2, of the Code of Canon Law, having before me the proposal of the Archdiocesan Standards and Recommendations Commission that SS. Cyril and Methodius Parish cease being a personal

parish and become a territorial parish with territory taken from St. Patrick Parish, Lemont, convened the Presbyteral Council of the Archdiocese of Chicago on November 5, 2019, at St. Monica Parish, Chicago, Illinois. There, after hearing the Presbyteral Council, receiving its vote of 34 for and none against the proposal, and invoking the Holy Spirit, I accepted the Presbyteral Council's advice and now

decree the following:

- 1. Effective July 1, 2020, SS. Cyril and Methodius Parish in the Village of Lemont, Illinois, will cease to be a personal parish and become a territorial parish with territory taken from St. Patrick Parish, also in Lemont, Illinois;
- 2. The mission of the former personal parish will be subsumed completely into the new territorial parish;
- 3. Each and all the parishioners of the present SS. Cyril and Methodius Parish and those living within the territory of St. Patrick Parish taken for the new territorial parish of SS. Cyril and Methodius are fully and equally parishioners of the new territorial parish;
- 4. The territory of the new territorial parish of SS. Cyril and Methodius will be the territory within these boundaries:

Start at Czacki Street and McCarthy Road,
East on the south side of McCarthy Road to Parker Road,
South on the west side of Parker Road to Will-Cook County Line,
West on the north side of Will-Cook Line to extension of Hillview Drive, and
North on east side of extension of Hillview Drive and Czacki Street to McCarthy Road.

- 5. Subject to the intention of founders and donors, and with due regard for any acquired rights, the goods and patrimonial rights of the former personal parish of SS. Cyril and Methodius, together with any obligations with which they may be burdened, will become those of the newly established territorial parish of SS. Cyril and Methodius in Lemont (see canon 121);
- 6. The documents given to the Presbyteral Council on this matter, together with the minutes of the Council meeting of November 5, 2019, will be attached to this decree;
- 7. The sacramental records and other materials relevant to historical research concerning the former personal parish of SS. Cyril and Methodius will be held and continued by the new territorial parish of SS. Cyril and Methodius;
- 8. Notification of this decree will be given immediately to the pastoral leadership of SS. Cyril and Methodius Parish and St. Patrick Parish, both in the Village of Lemont, Illinois, and to the parishioners of the two parishes. Publication will be made through the parish bulletins, and generally on the archdiocesan website.
